BILLING AGREEMENT

Authorization: I hereby authorize Greenwood Athletic and Tennis Club (the "GATC") to charge my checking account or Visa/MasterCard/American Express account as indicated on the front page. Generally, this will occur between the 2nd and 5th day of each month. I understand any billing changes must be made prior to the first day of each month (downgrade from family to couple, couple to single, etc.) as there will be no refunds given post billing. Cancellation of a full membership must still follow our resignation policy of a full calendar month's notice as indicated below under our Resignation Policy. By selecting the electronic funds transfer from my checking account, I understand that club miscellaneous charges may not be deducted from my checking account and must be paid for at the time of purchase. I am responsible for notifying the GATC of any changes in account numbers, bank information or closed accounts. I further understand that I will be responsible for any associated return and/or late fees assessed. By selecting the electronic funds transfer from my Visa/MasterCard/American Express account, I hereby authorize in-house charges to be debited directly from my Visa/MasterCard/American Express account on a monthly basis. I will notify the GATC of any lost or stolen cards, changes in account numbers, and new expiration dates. I further understand that I will be responsible for any associated return and/or late fees assessed.

MEMBERSHIP AGREEMENT

The GATC is a public facility owned and operated by the Greenwood Athletic Club Metropolitan District (the "District"). In accordance with my decision to use the GATC, I hereby acknowledge that a copy of the Greenwood Athletic and Tennis Club Policies and Rules, Greenwood Athletic Club Youth Policy and the Youth Handbook (collectively, along with any future adopted rules and regulations, the "Rules and Regulations") has been made available to me and can also be viewed online at www.greenwoodatc.com, and I agree to abide by the Rules and Regulations. I further acknowledge that these are subject to change at the discretion of the GATC management. In consideration of access to and use of the facilities, equipment, events or activities, and the services of JAG Management Group, LLC, the GATC, the District, their agents, owners, officers, managers, volunteers, participants, employees, independent contractors, consultants and all other persons or entities acting in any capacity on their behalf (herein collectively referred to as "Releasees"), I hereby agree, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representatives and estate as follows:

1. I hereby acknowledge, understand and assume the risks and potential dangers arising from the conditions and use of GATC facilities, equipment and premises, including without limitation swimming facilities, inflatable devices and other amusement activities, and participation in GATC events and or activities, which may occur on, off, or about GATC premises. Furthermore, I hereby acknowledge that the risks include, among other things: drowning; slipping and falling; collision with fixed objects or people; the exposure to insects; exposure to the elements could cause cold water shock, sunburn, dehydration, heat exhaustion, heat stroke, and heat cramps; ability to swim and/or follow directions; falling off of or being thrown from the inflatable; strains, sprains, broken bones and musculoskeletal injuries including head, neck, and back injuries; cuts, abrasions, and bruises; cardiac related illness; the negligence of participants, or other persons who may be present; equipment failure or operator error; my own physical condition, and the physical exertion associated with this activity.
2. I acknowledge and understand that included within the scope of this waiver and release is any cause of action arising from the performance or failure to perform construction, maintenance, inspection, supervision or control of GATC facilities, equipment and premises and/or from the failure to warn of dangerous conditions existing at said facilities, equipment or premises.
3. I hereby voluntarily relinquish and release, discharge, and agree to indemnify and hold harmless, now and forever, Releasees from any and all claims, demands, liability or causes of action for personal injury, property damage, or death occurring to me or to anyone else, by whomever or wherever made or presented caused by or arising from my presence at or use of the GATC, or GATC facilities, equipment, events, programs or activities, which may occur on, off, or about GATC premises, including but not limited to injury or damage caused by negligence or omission on the part of Releasees.
4. Should Releasees or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I hereby certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against Releasees, I agree to do so solely in the state of Colorado, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.
7. I hereby consent that photographs and/or video taken by GATC may be used by GATC for promotional materials, including the website. I understand that these photos and/or videos will be used only for promotional purposes, and will not be given to other parties for any purpose other than to promote the GATC. I may request that GATC cease from using any particular photo or video in future materials or promotions, by providing written notification to the GATC General Manager or Director of Marketing. Materials that are already in existence or production at the time I provide such written notice may continue to be used until supplies are exhausted.
8. I hereby agree to abide by the rules and regulations of the GATC as they may be amended from time to time.
9. This agreement and the rules and regulations of the GATC, as adopted and amended from time to time, set forth the entire agreement between the Releasees and me regarding liability. I have not relied on any representations made by or on behalf of the Releasees regarding this agreement. Nothing herein shall be deemed a waiver of the rights, privileges and limits on liability provided to the District by the Colorado Governmental Immunity Act, section 24-10-101, et seq., C.R.S.
10. I authorize the Releasees to contact me via telephone call or message or via e-mail at the phone number and e-mail address provided.
11. I have had sufficient time and opportunity to read this entire agreement. I have read and understood it and agree to be bound by its terms.

MEMBERSHIP AGREEMENT FOR MINORS

I am the parent/legal guardian of the minor child(ren) listed on this membership. RESIGNATION POLICY

As a member of the GATC, I accept the following resignation policy. Should a member need to resign a membership, the account balance must be paid in full and the membership must be resigned, in writing, a full billing cycle in advance (e.g. any member resigning between January 2-January 31 will be billed for February). Written resignations may be submitted to the GATC cancellation department by hand delivery, First Class U.S. Mail or electronic mail (cancel@greenwoodatc.com). A confirmation receipt from the GATC cancellation department must be received to confirm resignation. Oral resignations will not be accepted. If I am unable to meet the deadline and/or requirements, I accept the responsibilities of membership for the extra month including the payment of dues. If I have prepaid my membership and choose to change my status to month-to-month at the end of my term, I must abide by the resignation policy as stated above. Prepaid memberships are non-refundable and non-transferable.

ASSOCIATE MEMBERSHIP

I further understand that this policy applies once ANY member of an Associate Dual or Family membership reaches the age of 28 (twenty-eight).
